A new layer of transparency appears in the white area of the Photoshop file beneath the image you are editing. You can add, position and move multiple layers as the drawing progresses. Using the Selection tool To add an object to the layer, use the Selection tool. The Selection tool allows you to draw over any object (such as a person's head) and drag it into the layer you are working with. Layers panel To change the properties of the selected object, double-click the color for the selected object. The color panel opens, displaying the item's color in a hexadecimal or RGB format. You can change the settings for color, brightness, contrast, saturation and hue with these features. You can click the Save or Undo icon in the top-right corner of the Layers panel to save the changes or undo them. To create a new layer, click the New Layer icon (in the white area) in the Layers panel. As you drag over the edge of an object to select it, it turns blue to show you where it will be added to a new layer. You can add a layer of a different size and location with the Layer Mask feature. What's New In Photoshop 2022 (Version 23.0)?

On Wednesday, the Supreme Court ordered a lower court to fix a mistake. By a 5 to 4 decision in *Walker v. Texas Division, Sons of Confederate Veterans*, the justices ordered the Fourth Circuit Court of Appeals to confirm that a court can permit a religious group to keep the Confederate flag off its property. The case is significant for a couple of reasons. It marks the Court's first order requiring a lower court to allow a religious group to assert a neutral, viewpoint-neutral principle in response to a government rule. It shows the Court has shifted somewhat in its view of the issue. In 2015, in a case that involved allowing a group of Christian bakers to refuse to bake a cake for a same-sex wedding, the Court said it was a "religious, not a racial, neutral principle." In this case, the court is not overtly saying the Confederate flag is a religious symbol. In fact, the judges cite Article VI of the Constitution, which bans religious tests for office, as a standard for judging the Confederate flag. But they say that the Supreme Court has long held in cases similar to this one, that the government "cannot single out these particular religious objects or religious uses for disfavored treatment." But the Court also concluded that its decision wasn't too broad. In that 2015 case, the majority had written that the First Amendment barred religious displays that were "motivated by an intent to convey a religious statement," such as a sign saying "No God but God." The Fourth Circuit had argued that sign was in fact an endorsement of a religion, and thus was not protected by the First Amendment. The Court majority in the new case, however, said "a refusal to sell a specific good in response to a general request is not the same as a display of a broad message; it is akin to an individual declining to distribute campaign literature." That's a fairly standard reference to the Court's free-speech jurisprudence. The First Amendment bars the government from prohibiting a speaker's message. Justice Neil Gorsuch, however, wrote a dissenting opinion that said the majority's decision did not necessarily protect the right of a religious group to keep its identity by allowing it to keep the Confederate flag. Gorsuch said the Fourth Circuit's decision -- which had upheld the lower court's order allowing the group to keep the Confederate flag -- was "ultimately no more than a determination that Texas violated the Fair Housing Act
